### Vendor and Saddle Club Rules and Regulations

All exhibitors and food vendors must be approved through a juried application process. The Georgia Junkies 41 reserves the right to accept vendors according to the specific needs of the show. There are more outdoor spaces than indoor, so requesting an indoor space does not mean you will be granted one. The Georgia Junkies 41 will tell you at the time of acceptance if you have an indoor or outdoor space and you will be given the opportunity to decline the booth that is available if it does not fit your needs.

Exhibitors requesting electricity understand that they will be charged \$10.00 per day per plug in accordance with the rules of the Bartow County Saddle Club. The Saddle Club board will be counting plugs in use on all three days.

There is a \$25.00 administrative fee for all returned checks.

Food vendors are strongly encouraged to use quiet generators rather than electricity. The Georgia Junkies 41 reserves the right to determine if the generator is too loud for customers.

The Georgia Junkies 41 does not provide tables, chairs, or tents. Vendors must supply their own. We ask that vendors bring tents for outside the arena that are solid in color.

The Georgia Junkies 41 will have some loaders available to help get your large and/or heavy pieces to your booth at set-up and from your booth during tear-down. However, there will not be enough man power for our loaders to help vendors set up booths. Tips for the loaders are greatly appreciated at both set-up and tear-down as these kids are in college and are working as volunteers at the event. Please be considerate of their time as they will be helping all vendors throughout the three-day move in period. Vendors need to come prepared with their own wagons or carts needed to move smaller merchandise and boxes into booths.

Booths must be occupied at all times during the event. If vendors need breaks, they will ask a worker or one of the Georgia Junkies to sit in booth during that break.

It is critical that set-up and tear-down run smoothly as there are only four entrances into the arena. Outside vendors can set up and tear down according to the time needed to be prepared to open at least 15 minutes prior to the start of the show each day. Indoor vendors will be given a specific move-in plan so all vendors have the same opportunity to set up shop. Vendors will need to pull up to the suggested gate, back in, unload all merchandise, move car, and then set up booth. Please be courteous to others who need to do the same. The Georgia Junkies 41 will ask for your requested move-in time preference, which will begin at 3:00 on Wednesday, October 16<sup>th</sup>, and run through 2:00 on Friday, October 18<sup>th</sup>. **ALL VENDORS MUST BE SET UP NO LATER THAN 2:00 ON FRIDAY, OCTOBER 18<sup>TH</sup>!** Food vendors will have a health inspection at noon on Friday. Any food vendor not set up and prepared for the health inspection will be asked to leave the market without return of funds.

You may drive up to arena to load and unload, but all vehicles are prohibited to drive into the arena.

In accordance with Saddle Club rules: No alcohol or firearms on premises. All dogs must be on a leash at all times.

All booths MUST remain up until 4:00 pm on Sunday, October 20<sup>th</sup>. By dismantling your booth early, you are not only affecting the quality of the show, but also forfeiting your chances to participate in future events.

Each vendor will receive two vendor lanyards. These are for you and a partner who will be helping at the show. Should you need extra lanyards for more workers, you will need to purchase them for \$5.00 each from one of the Georgia Junkies 41 team members. All lanyards will be returned at the end of the show. These lanyards will get you into the gate for free each day, but without them, you will be charged. It is important to wear them all weekend.

NO GUESTS WILL GET INTO THE EVENT FOR FREE. Please do not tell friends, workers, family members that they can get in free by dropping your name. The workers are under strict guidelines to let no one in for free except for those with vendor or volunteer lanyards.

Exhibitors and food vendors are responsible for collecting sales tax. Tax representatives may or may not visit the event. Be prepared to show paperwork if you are asked. Bartow County sales tax is 7%.

Once you apply the Georgia Junkies 41 will jury your application and will send you an email announcing you are accepted, on a wait list, or not accepted. Booth space is confirmed when organizers receive full payment and a signed contract. If payment is not received within 10 days of acceptance, your application will be removed and you will have to begin the process over again. We will not save spaces inside or outside after the 10<sup>th</sup> day.

The Georgia Junkies 41 reserves the right to remove any vendor from the event who does not adhere to all the rules and regulations set forth in this document. We kindly ask that all vendors are considerate of the Saddle Club, each other, our customers, and the Georgia Junkies 41 workers.

The Georgia Junkies 41 and any and all persons, property owners, suppliers, employees, volunteers and entities associated with the Georgia Junkies 41 Vintage Markets are not liable for any damages, injury, or loss to any person or goods from any cause whatsoever. All exhibitors, vendors, their heirs, administrators and executors do hereby waive and release all of the above named from any and all claims for damages of whatever arising out of the exhibitors' participation in the Georgia Junkies 41 Vintage Markets. Vendors should obtain at their own expense insurance against loss, damage, or injury that they may require.
